

## Terms & Conditions for Cashback Campaign on Instant credit card Activation

## (February 2019)

## Terms and Conditions for Credit Card Users:

- Offer: Get Rs.100 cashback on first transaction of minimum Rs.300 within first 60 minutes using Axis
   Bank Instant credit card (Virtual Credit Card)
- o Offer Period: 60 minutes from credit card issuance time
- The transaction should be customer initiated only and can be an online / offline / point of sale purchase transactions
  only. Any cash withdrawal, fee or financial charges levied by the bank would not be eligible for this campaign.
- Transaction has to be done on the Instant Virtual credit card number only.
- · This offer is valid only for Instant credit cards issued by Axis Bank.
- · Cardholder's eligibility for the offer will be decided by the Bank.
- The cashback amount will be credited within 60 days to all eligible customers, after the expiry of the offer period on best effort basis.
- · All escalations related to this campaign will be valid within 6 months from the end of the campaign period.
